In accordance with BSNL, Corporate Office, ND orders cited under reference, the executives in the cadre of JTOs(T) mentioned in Annexure are hereby promoted to the grade of SDE(T) against vacancies year 2010-11 under Competitive Quota (33%) in the IDA Pay Scale (E2A) of Rs.20600-46500/- from the date they assume charge of the higher post and posted as mentioned against their names subject to the following conditions.

I.

1. They have been absorbed in BSNL on permanent basis.
2. No Disciplinary/Vigilance case is pending against him/her and no VC is withheld in terms of instructions issued by D.G P&T/DoP&T vide O.M dated 28.04.2014 and from time to time.
3. The currency of any penalty against the officer is over.
4. The officer is not on deputation to TCIL or any other organization.
5. The officer has not retired on the date of issue of the order.
6. The officer has not resigned from the BSNL services.
7. They have fulfilled the prescribed eligibility of three years regular service as per SDE(T) RRs.
8. The Officer has submitted the undertaking as per the enclosed format.

II. Corporate Office, New Delhi will decide such cases as detailed in Para 1 supra on receipt of information from Concerned Telecom Circles/SSAs from where he belongs. Information in this regard may be brought to the notice of this office immediately and the concerned officer should not be promoted or relieved for posting without specific orders from this office.

III. The Promotion Order is issued subject to the vigilance clearance and submission of necessary undertaking in the prescribed format(enclosed) as per the directions of Hon'ble CAT Chandigarh judgement in OA No.060/00133/2015. In case of executives on deputation within BSNL, the vigilance clearance should be obtained from the recruiting circle also.

IV. The SSA Heads concerned may ensure eligibility conditions are fulfilled in respect of the executives promoted and arrange for relief in time to enable the executives to join their promotional assignment, and the officer is relieved within the prescribed time limit of 40 days (including the joining time) from the date of issue of this order by BSNL Corporate Office, New Delhi.

V. In case the Executive concerned fails to join the promotional assignments within the prescribed period of 40 days (including the joining time) from the date of issue of order by BSNL, Corporate Office, New Delhi., he/she should not be allowed to be relieved or join the post thereafter. In such a case, the promotion order shall become inoperative and the matter shall be reported to this office for further necessary action.

VI. The date on which the above order is being given effect by the SSA/Unit may be intimated to this office and accordingly a consolidated report of the officers who have been relieved and have joined their new postings on promotion may also be forwarded to this office for onward transmission to BSNL, Corporate Office, New Delhi.

VII. The Seniority of the officers promoted under this order shall be determined in accordance with the rules in force and will be issued separately.

VIII. The aforesaid promotion order is subject to final outcome/decision in any Lawsuit(s) pending before any Hon'ble Court(s) regarding their regulation of seniority etc.

IX. The relieving and joining particulars of the officers may be updated in ERP/Service Records.

X. Pay fixation on promotion will be made as per prescribed norms.

This issues with the approval of the Competent Authority.


