Sub :- Promotion and Posting of JTOs to the grade of SDE(Telecom) in BSNL against 67% Seniority -cum-fitness IN AP Circle-Reg

In accordance with BSNL, Corporate Office, ND orders cited under reference 1, the executives in the cadre of JTOs(T) mentioned in Annexure are hereby promoted to the grade of SDE(T) against 67% Seniority-cum-fitness Quota in the IDA Pay Scale of Rs.20600-46500/- from the date they assume charge of the higher post and posted as mentioned against their names subject to the following conditions.

**I.**

1. They have been absorbed in BSNL on permanent basis.
2. No Disciplinary/Vigilance case is pending against him/her and no VC is withheld in terms of instructions issued by D.G P&T/DoP&T vide O.M dated 28.04.2014 and from time to time.
3. The currency of any penalty against the officer is over.
4. The officer is not on deputation to any other organization.
5. The officer has not retired on the date of issue of the order.
6. The officer has not resigned from the BSNL services.
7. They have fulfilled the prescribed eligibility of three years regular service as per SDE(T) RRs.

**II.** In case of any executive falls within the instructions contained in DOPT order dated 14.09.1992 as referred above or are under currency of penalty, their promotion order may not be given effect and information in this regard may be brought to the notice of this office immediately along with the details of prosecution /suspension/disciplinary case under currency of penalty, if any as the case may be.

**III.** The SSA Heads concerned may ensure eligibility conditions are fulfilled in respect of the executives promoted and arrange for relief in time to enable the executives to join their promotional assignment, and the officer is relieved within the prescribed time limit of 40 days (including the joining time) from the date of issue of this order by BSNL Corporate Office, New Delhi 15.06.2018.

IV. In case the Executive concerned fails to join the promotional assignments within the prescribed period of 40 days (including the joining time) from the date of issue of order by BSNL, Corporate Office, New Delhi., he/she should not be allowed to be relieved or join the post thereafter. In such a situation, the promotion order shall become inoperative and the matter shall be reported to this office for further necessary action. Further, no request for modification of posting order shall be entertained. Accordingly, promoted officers should join the assigned posting without fail.

V. The leave, if any requested by the officer, who has been posted on promotion should not be allowed. If any officer desires leave, he / she can apply for leave to new place of posting under whom he/she has been posted only after joining the new assignment. The new controlling officer will sanction leave, if it is considered justified as per norms.

VI. Discrepancies regarding name, gender, present SSA/Unit etc in the annexure may be intimated to this office immediately for issuing necessary correction. A copy of charge report submitted by the promoted officer may be endorsed to this office

VII. The date on which the above order is being given effect by the SSA/Unit may be intimated to this office and accordingly a consolidated report of the officers who have been relieved and have joined their new postings on promotion may also be forwarded immediately on expiry of 40 days from the date of issue of BSNL, Corporate Office, New Delhi order dated 15.06.2018.


VIII. The aforesaid promotion order is subject to final outcome/decision in any Lawsuit(s) pending before any Hon'ble Court(s) regarding their regulation of seniority etc.

IX. The relieving and joining particulars of the officers may be updated in ERP/Service Records.

X. Pay fixation on promotion will be made as per prescribed norms.

XI. As per CO ND letter cited at reference 2, the reallocation of circle in the grade of SDE (T) cadre will be carried out latter by CO ND. In this regard, the said Promotion/Postings have been issued on "As is Where is basis". Accordingly posting may be given at SSA level without changing the headquarters till further orders for promoted JTOs (T) to the grade of SDE (T) against 67% seniority-cum-fitness quota as per annexure enclosed and for promoted JTOs (T) to the grade of SDE (T) under competitive quota (33%) on the basis of Limited Departmental Competitive Examination held on 21.06.2015 circulated vide letter TA/CO-VJ/admn/LDCE/SDE/2017-18/10 dtd 14.06.2018.

This issues with the approval of the Competent Authority.


